The quotations will be received on or before 23-06-2015 upto 01:00 PM and shall be opened on same day at 03:30 PM in the presence of intending suppliers or their authorized representatives.

The following instructions should be strictly observed for submitting the quotations failing which the quotations shall be liable for rejection.

1. The quotations shall be submitted in the O/o Superintending Engineer, IIT Mandi at Kamand campus, Mandi (H.P.) Pin-175005 in a sealed envelope duly marked "Quotation against enquiry no. \_\_\_\_\_ dated \_\_\_\_\_ due on \_\_\_\_\_" on the corner of the envelope.
2. Quotation received after closing date/time will not be considered.
3. The rates quoted should include transportation costs upto IIT Mandi (Kamand campus).
4. Rates of sales tax/VAT or any other taxes and duties should be clearly mentioned.
5. Rates quoted should be valid for at least 45 days from the date of opening of quotations.
6. The rates must be quoted both in figures and words and over writing should be avoided. However all cuttings/corrections must be duly authenticated.
7. The quantity shown against items is approximate and may vary as per demand of the department at the time of placing the order.
8. Delivery should be completed within 30 days of issue of supply order.
9. The IIT Mandi reserves the right to reject any quotation wholly or partly without assigning any reason.
10. Normally, payment will be made on receipt of material and check with regard to quality and quantity of the material supplied and on submission of pre- receipted bill by the firm.
11. L.D. Charges will be 1% per week or part thereof subject to maximum of 10% will be imposed if material is not supplied within stipulated delivery period.
