- Fine quality viz. Stoneware/ Chinaware Crockery with SS cutlery & Good glassware for VVIP Service.
- Drinking water arrangement will be arranged by the service provider/vendor.
- Soiled cutlery bins need to be arranged at service area.
- Cloth napkins and good quality white paper napkins need to arrange by caterer.
- Caterer must provide service staff to take care of all the arrangements.
- Servers must be in proper uniform and well groomed.

Additional instruction, terms & conditions are given below for providing catering service during the event.

- Bid Security Declaration: All prospective bidders registered with MSME / NSIC are required to provide bid security declaration as per **Annexure-II** failing which their bid will be treated as non-responsive and will be rejected.
- Serving arrangements for VVIP guests need to be made by the vendor.
- Cooking utensils, fuel & other arrangements are to be taken care by the vendor himself.
- 6 drinking water dispensers with disposable paper water glasses.
- 6 well laid buffet counters shall be required with minimum 3 persons available in each Counter. The Vendor should provide clean cloth and cover for each counter.
- At least 1-Captain should be there for each counter.

- Sufficient numbers of garbage bins should be provided and cleanliness should be ensured.
- The products supplied should be of good quality and hygienic.
- The quantity, venue, date and/or time may change to the requirements of the Institute.
- In case of change in quantity, the vendor must be able to make arrangements at very short notice.
- The food should be served only to the coupon bearers and the vendors should provide service to collect coupons. Final bills shall be settled against the collected coupons only.
- Vendors should have experience of providing services in the academic institute or any government organisation preferably for 800 or more people. A certificate or copy of order must be attached with the offer. In the absence of proper proof of experience, the bid will be treated as disqualified and cancelled.
- A copy of FSSI and GST registration certificate should be attached.
- The bidders are to provide all requisite certificates and details within time in sealed cover only. No additional time will be given to supply the additional documents.
- In the event that any of the above terms and conditions listed above are not fulfilled, the committee may decide to bill in part or apply penalty.
- The Institute reserves the right to select/reject any bid solely with its satisfaction and discretion. Lowest rates quoted by the vendor will not be considered as the only criteria to award the contract.

Note: The bidders are requested to read the entire document carefully and ensure compliance with all instructions therein. Non-compliance with terms and conditions mentioned in this document may lead to disqualification.
