- 1. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 5. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 7. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The successful bidder is required to provide bedding items of neat & clean, hygienic conditi on, free from bad odor, free from dirt spots and torn conditions. Further, for the long-durati on events (exceeding one week) of the Institute, the bidder is required to provide timely wa shing of the bedding items or to replace the used ones as & when informed by the Institute official.
- 2. **Payment:** On bill basis after satisfactory completion of assigned work/services duly certifie d by the IIT Mandi official.
- 3. **Performance Security:** A performance security deposit is required to be submitted by th e successful bidder for the 10% of the contract order value in the form of Bank Guarantee / FDR pledged in favor of "The Registrar, IIT Mandi" issued by any scheduled / nationalized b ank in India. The performance security should remain valid 60 days beyond the contract du ration. And the same will be returned on completion of the contract obligations. No interest shall be paid on the Performance Security submitted.
- 4. In case of non-execution of the contract / withdrawal of the bid between the bid processing the EMD will be forfeited and legal action may be taken against the bidder.
- 5. Successful bidder after the award of the contract is required to maintain cleanliness and hy giene while providing the contract ordered items during the events / workshops at IIT Mand i.
- 6. **Penalty:** A penalty of 1% of the total order value per week shall be levied for the delay su bject to a maximum of 10% of the total order value. In case of the non-supply of the item a fter the acceptance of the work/supply order, EMD will be forfeited by the Institute.
- 7. **Force Majeure:** For the purpose of and within the scope of contract by way of indication a nd not of limitation, the term "Force Majeure" shall mean acts of nature, strikes, Lockouts, or other industrial disturbances, act of public/enemy, wars, blockades, insurrection, riots, e pidemics, landslides, earthquakes, storms lightening, flood, washouts, civil disturbances, e xplosion and any other similar even not within the control of either party on which by exerci se of due care and diligence neither party is able to prevent or overcome.
- 8. **Arbitration:** If any dispute which may arise with respect to any term and condition or with respect to the interpretation of any term and condition of the Purchase Order/Work Order, which may be issued to the qualified and successful tenderer subsequently, the same shall

be settled strictly in accordance with and in compliance of the Arbitration procedure which is mentioned descriptively in the Purchase Order/ Work Order.

## 9. Criteria for bid rejection:

- a. If a technical bid is found without the required undertaking in respect of acceptance of the bid conditions, EMD.
- b. If it is found at a later date that any information given in the bids is Incorrect/false then the bid is liable to be disqualified/rejected.
- c. Canvassing in any form will result to disqualification.
- d. If "extra, as actual" etc. are mentioned against any of the price components in the bid the bid will be rejected.
- e. If the firm quotes 'NIL' charges / consideration, the bid shall be treated as unresponsive and will not be considered.
- f. If the financial offer is found along with technical bid, then the bid shall be rejected outrightly.
- g. If any bidder submits two/multiple bids for the same item of a tender, both/all the bids o f that bidder will be outrightly rejected.
- h. The decision of the institute in all matters relating to eligibility, acceptance, rejection of the bid will be final and binding on the applicants.
- 10. The quantity shown against the item is approximate and may vary as per demand of the In stitute at the time of placing order. Also, the final requirement of each line item will be decided by the Institute at the time of placing the PO.
