Objectives of Memorandum

NITTR, Bhopal and IIT Mandi are government institutions created through the act of Central Government. Recently, NITTR, Bhopal has achieved the de jure university status under Direct Category to promote and support excellence in technical education. In view of excellence in both institutions, the two institutions have agreed to cooperate in the following manner:

and

- Exchange of faculty and staff for the purpose of research, teaching and consultancy, with prior approval from both institutions for a period of one year.
- Joint supervision of postgraduate students as per the norms of both institutions.
- Permissible exchange of scientific information for academic purposes.
- Utilization of research facilities at special charges applicable to IIT Mandi.
- Training of staff on facilities of both institutions is subject to the availability of resources.
- Joint research activities through participation in inter-institutional and interdisciplinary projects.
- Organization of joint symposia, seminars, workshops, conferences, training programs etc.
- Exchange of students for the purpose of transfer of credit and other activities as per the norms of both institutions.

Objectives of Memorandum of Understanding:

NITTTR, Bhopal and IIT Mandi are government-funded institutions created through the act of Central Government. Recently, NITTTR, Bhopal has achieved the deemed University status under distinct category. To promote and support academics and research for the development of excellence in both institutions, the two institutions have agreed to cooperate in the following main activities.

- Jointly work on assembly and packaging of semiconductor devices and OSAT.
- Exchange visits of faculty and staff for the purpose of research, teaching and consultancy with prior approval from both the institutions for a duration of up to one year.
- Joint supervision of postgraduate and Ph.D. students as per the norms of both institutions.
- Permissible exchange of scientific information for academic purposes.
- Utilization of research facilities at special usage charges applicable for H.P. users.
- Training of students on facilities at both institutes is subject to the availability of resources.
- Joint research activities through participation in nationally and internationally funded projects.
- Organization of joint events such as seminars, workshops, conferences, training programs etc.
- Exchange of students for 1st or 2nd semesters for course work and projects with the possibility of transfer of credits as per the norms of the institutions.
- Any other objective as agreed upon writing by both the institutions.

1. Financial Arrangements:

Both parties acknowledge and understand that all financial arrangements, if any, will be subjected to prior written agreement and availability of funds for each activity undertaken.

2. Duration Renewal:

The MoU is signed initially for five years at the first instance from the date of signing. Further continuance of this MoU will be subject to joint agreement and review by both parties to be undertaken before the expiry of this MoU.



3. **Advertising and Publicity:**
Both the institutes may advertise this MoU for information of students, faculty, staff and the general public.
4. **Modification of MoU:**
This MoU may be modified at any time if circumstances arise which call for any alteration subject to the approval of both parties.
5. **Statutory Compliance:**
This MoU solely expresses the intention of both institutions. It is agreed that it does not have a legal effect nor create any financial obligations on either institution.
6. **Confidentiality:**
Both institutions agree and undertake to keep confidential any information/ data exchanged, acquired, or shared in connection with any program or activity conducted under this MoU.
7. **Governance:**
All terms of this MoU are subject to the laws of the Republic of India and acts, statutes and ordinance of both the institutions.
8. **Signature on MoU:**
Both the institutions agree to execute the objectives of the MoU within the framework of terms of reference of this agreement.

Based on the above promises the parties put their signatures in this MoU on 26/04/2024.
